Dear Parent/Guardian,

I am pleased to be able to inform you about a planned Art visit which has been arranged for our Year 10 Visual Arts students to Liverpool Tate Gallery on Tuesday 28th January 2020.

We would like to leave school promptly at 8:40am; therefore students should arrive to the rear entrance of school on the morning of the trip by 8:30am at the latest. It will take approximately one and a half hours to get to Liverpool ready for when the gallery opens at 10:00am. Students will have the opportunity to look around the gallery, taking inspiration from the work on display and to complement their contextual studies work which they have been doing this year. An element of the exam course requirement is that students get to see art work at first hand so this is a great opportunity for students to do this. We will take a break for lunch at 12:30pm; students should either bring a packed lunch to eat or some money to purchase food from the gallery café or one of the many cafés on the Liverpool Docks – they will be allowed to go in small groups to get something without actually leaving the docks themselves.

Students will continue to complete work in the afternoon, between 1:30pm and 3:30pm, prior to setting back off to school at approximately 4:00pm. It is intended that we will be back at school between 5:30pm and 6:00pm therefore students will need to be collected from the bus bays on Free School Lane at this time or you will need to ensure you have made suitable arrangements for your child to get home safely from this time. Students will be told to contact parents when we are approximately 30 minutes away from school to ensure you have enough time to arrive at school to collect your child.

The cost of this visit is just £14.00, which is to cover the cost of the coach transfer to Liverpool. Entrance into the Tate Gallery is free. Please could I politely ask for you make a voluntary contribution of £14.00 via Parent Pay at a convenient time before 17th January 2020 and also complete and return the V4 form? I will need final numbers attending the trip by the 22nd January, so I can confirm with the coach company. Should there be insufficient funds to cover the cost of the trip, I will unfortunately have to cancel it.
